### Majority 6-3 opinion

Congress did not authorize the devising emissions caps based on the generation shifting and therefore the EPA has overstepped their approach



### Majority 6-3 opinion


The Constitution neither mandates nor permits the government to censure religious expression, therefore school staff cannot be prohibited from exercising their religion on school grounds, as long as they are not acting in their official staff role.

Pobbs V Jackson Women's Health Organization


Majority 5-4 Opinion

Abortion is not a right designated to people as outlined in the Constitution, and therefore should be entirely a state decision

#### Shurtleff v Boston

### unanimous 9-0 opinion

The city must raise the flag of the Christian group

Let government buildings promote Christianity, but let's not mention other religions





New York should be able to pass legislation that restricts gun use in order to minimize the number of deaths #sensible

The right to bear arms is deeply rooted in our nation's history. That cannot be infringed upon further than background checks, training, fingerprinting, and a health records check. #2ndamendment

New York State Rifle & Pistol Association V Bruen

#### Majority 6-3 Opinion

New York's proper-cause requirement for an unrestricted concealed carry license prevents people from exercising their Second Amendment right and is therefore unconstitutional

Guns are helpful, not harmful



Legal question: is the issuing of a censure resolution, in response to another member's speech, a violation of the First Amendment?



Censure is not a violation of the First Amendment. The powerful can tell those beneath them how to behave.


